 Carer Premium – payable where claimant or partner is receiving (or treated as receiving) Carers Allowance /Carer Support Payment.

#### **ESA component** (only one component per couple)

- work related activity payable if <u>claimant</u> in work related activity group and their period of limited capability for work started before 3<sup>rd</sup> April 2017
- **support** payable if <u>claimant</u> in support component.
- **Enhanced Disability Premium** payable if not entitled to Pensioner Premium and:
  - claimant gets support component of ESA, or
  - <u>claimant or partner</u> entitled to the <u>enhanced daily living</u> component of PIP/ADP / <u>high rate care</u> component of DLA, or Armed Forces Independence Payment.

## Severe Disability Premium – Single person

- No non-dependant\* aged 18 or over is normally residing with tenant, and
- Claimant receives a qualifying disability benefit # and no-one gets paid Carers Allowance/Carer Support Payment or has Carer Element in UC claim for looking after them.

#### **Couple, single rate** – one qualifies, is paid where:

- No non-dependant\* aged 18 or over is normally residing with them, and
- One gets a qualifying disability benefit #, no-one gets <u>paid</u> Carers
  Allowance/Carer Support Payment or has Carer Element in UC claim for
  looking after them, and the <u>other is certifies as severely sight impaired or</u>
  <u>blind</u>. OR
- <u>Both</u> get a qualifying disability benefit # but Carers Allowance/Carer Support Payment is being <u>paid</u> or Carer Element in UC claim paid to a carer looking after <u>just one</u> of them,

#### Couple, couple rate is paid where:

- No non-dependant\* aged 18 or over is normally residing with them, and
- <u>Both</u> get a qualifying disability benefit # and no-one gets <u>paid</u> Carers
  Allowance/Carer Support Payment or has Carer Element in UC claim for
  looking after either of them.

#### Pensioner Premium -

- payable where partner has reached 66.
- (Cannot get the Disability or Enhanced Disability Premium)

- Attendance Allowance
